**Section 4 - FIRST AID MEASURES****General Information:**

## Section 6 - ACCIDENTAL RELEASE MEASURES

**Accidental release:** In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. There are no specific manufacturer recommendations for protective equipment materials. Use impermeable gloves with care. Eye/face protective equipment should comprise as a minimum, protective glasses and, preferably, goggles. If there is a significant chance that dusts are likely to build up in clean-up area, we recommend that you use a suitable Dust Mask. Otherwise, not normally necessary.
